It is nearing mid November. It is hard to believe that we have come thus far and done so well with regards to the pandemic that hangs over the world. I want to thank our parents for their cooperation through these first 12 weeks. We have been more than fortunate at our little school. We have seen school districts all over NW Missouri dismiss classes and quarantine their students on and off since the first week of school. We, on the other hand, have avoided a mass loss of students and we hope for continued cooperation and success.

National health experts have suggested that American families consider scaling back their Thanksgiving and holiday gatherings. Personally, I think families should, and will, gather for the upcoming holiday season regardless of what any expert tells us to do. We believe this is a good way to prevent exposing all of our students to the possibility of contracting the COVID-19 virus. We are giving up 4 days after Thanksgiving in hopes these days will allow us to remain in school until Christmas. Thus, the trade-off.

Some schools have a spring break. We'll have a fall break. Hopefully, you will now understand the logic behind this move. It is my sincere hope that by the time Easter rolls around, we will not have to do this again. However, that too, is beyond our control. One thing that we can control is our sincere gratitude for being able to have a family gathering at Thanksgiving if we so desire.

I end this with a quote from a child's book titled <u>In November</u> by Cynthia Rylant, "In November, people are good to each other. They carry pies to each other's homes and talk by crackling woodstoves, sipping

mellow cider. They travel very far on a special November day just to share a meal with one another and to give thanks for their many blessings – for the food on their tables and the babies in their arms."

Be kind to one another and give thanks for the many blessings we have been given that we, too often, take for granted.

School board Candidate Filing Opens in December

It's time to prepare for the April school board election. Candidate filing begins December 15, 2020.

- There are two seats up for election for a three year term.
- Filing began at 8 AM on December 15 and ends at 5:00 PM on January 19, 2021. On other days the district will only accept candidate filing during the business hours. (8:00 AM 4:00 PM)
- Filing will not occur on holidays and other days the district offices are closed, including on days in which the district is closed due to inclement weather.

The district will provide each candidate a copy of a summary of campaign laws provided by the Missouri Ethics Commission and written notice of the candidate's obligation to file a personal financial disclosure statement.

Information on the School Board Organization

The qualified voters of the School District shall annually on the first Tuesday after the first Monday of April, elect two directors for terms of three years, except, effective for Board elections beginning in April of 1993, and each three years thereafter, when three directors shall be elected in compliance with regulations specified in state law.

An election shall not be held if the number of candidates who have filed for the Board is equal to the number of positions available.

Qualified Voters in the School District

An individual must be a registered voter in order to vote in a school election. In order to vote, a person must be eighteen (18) years of age or older, must be a citizen of the United States, and must reside in the School District thirty (30) days.

Candidate Qualification - Method of Filing

Qualified applicants for the Board may file for office beginning at 8:00 a.m. in the Superintendent's office commencing on the sixteenth (16th) Tuesday prior to the election and ending at 5:00 p.m. on the eleventh (11th) Tuesday before the election. The candidate shall declare his/her intent to become a candidate, in person and in writing to the secretary of the Board of Education. The names of qualified candidates shall be placed on the ballot in the order of filing. The notice of election and certification of candidates must be submitted to the county clerk by the tenth Tuesday prior to the election. Candidates must comply with all of the prevailing laws concerning eligibility and campaign financing.

Candidates must be citizens of the United States and resident taxpayers of the District, reside in his/her state for one year next preceding their election or appointment, and be at least twenty-four (24) years of age. Each newly elected or appointed director shall qualify and take his/her oath of office in the manner prescribed by law and according to Policy 0330 - Oath of Office.

INDEPENDENT AUDITORS' REPORT ON MANAGEMENT'S ASSERTIONS ABOUT COMPLIANCE WITH SPECIFIED REQUIREMENTS OF MISSOURI LAWS AND REGULATIONS

To the Board of Education Avenue City R-IX School District

Professional Development News

The staff at Avenue City used a portion of the summer months to schedule virtual opportunities to view new math curriculum companies as well as look at updated options of companies that we currently use.
