



COVID - Is There Anything Else We Can Talk About?

The question looming over our community remains, "When are we going to get back to normal?" The answer to that question is "When were we ever normal? It's been so long ago; I can't remember what normal even looks like." One thing I do remember is a time when none of us chose to wear facemasks. The only facemask I ever chose to wear was connected to a football helmet. I suppose in that regard, both of these kinds of masks were invented for your protection. It is just my experience, that the one connected to the helmet was a lot more fun that the other kind.

For the past 20 months, we have waited for a chance to move away from required face masking. We longed for a day in the future, where we could have conducted a facemask bonfire. The introduction of the COVID vaccination for school-age children has opened a door for all of us. While some people think the COVID 19 vaccination is a miracle, others view it as another government conspiracy. I do not provide you with my opinion about vaccinating children against COVID-19. However, I do provide my opinion that *the opportunity* to take the vaccine does provide a pathway back toward normalcy.

The first week of November, the school was informed that the COVID vaccinations for students age 5 and above are or will be available. Allowing for the 20-day window to obtain a second vaccination means that those parents wanting their children to be vaccinated could have completed the process as early as the first week of December. Allowing an additional month for those desiring to get their children vaccinated will allow us to lift our mask requirements when we return from Christmas break. Therefore, beginning in January, the only place masks will be required to be worn at our school is on the school bus. This does not mean that the COVID pandemic is over. Because of the opportunity to receive a vaccination against COVID-19, we believe that we can return to the idea that parents should be determining whether their child wears a mask at school or not. The school has held the unpopular job of "mask police" for the past 20 months. If you are one of the parents who wanted your child (and everybody else's child) to be masked at school, I hope you are the first in line to obtain the vaccine. For those of you who do not want your children to be masked, that decision is yours beginning in January.

Realize that if we experience cases of COVID-19 at school or in the community, we may have to return to a policy that requires masks to be worn. As long as we are not experiencing a high rate of infection and/or school absences due to quarantines, we will leave the mask wearing decisions up to the parents. The decision to get the vaccination for your child is also a parent's decision; as it should be.

In conclusion, I wish to express my gratitude to our students, our staff members, our parents and our community who have done what was asked of them over the past two years. Your continued support and prayers are most appreciated.

"Test to Stay" is Coming

The "test to stay" program is an effort/opportunity for our students to avoid a COVID-19 related removal from school. Any student that is exposed to COVID-19 will need to follow the school's direction with regard to being removed from school. In most cases this would be for a 10-day period. During that time, the student will have no participation in school or extracurricular activities.

Avenue City R-IX Students will be offered the opportunity to participate in the "test to stay" program. The program is currently only available to students who have been exposed to a COVID-19 case at school or at a school event. HOWEVER, we are hoping to expand this program to any contact with COVID outside of the home. This program is not available for any student who is exposed to COVID by a member of their household.

Following each in-school-related exposure to COVID-19. Parents may "opt-in" to the program at the time that they are notified of their child's exposure to COVID-19. A parent signature is required to be part of the "test to stay" program. When you are in need of this program the details regarding test requirements will be provided. The "test to stay" is completely voluntary. The district is seeking funds to provide free COVID-19 tests for those families who find themselves in need of the "test to stay" program. It is our hope that this program can provide some peace of mind and be of assistance to our parents and our community.

INDEPENDENT AUDITORS' REPORT ON
INTERNAL CONTROL OVER FINANCIAL REPORTING
AND ON COMPLIANCE AND OTHER MATTERS BASED ON AN AUDIT OF
FINANCIAL STATEMENTS PERFORMED IN ACCORDANCE WITH
GOVERNMENT AUDITING STANDARDS

To the Board of Education Avenue City R-IX School District

We have audited, in accordance with the auditing standards generally accepted in the United States of America and the standards applicable to financial audits contained in *Government Auditing Standards* issued by the Comptroller General of the United States, the financial statements of the governmental activities and each major fund of Avenue City R-IX School District, as of and for the year ended June 30, 2021, and the related notes to the financial statements, which collectively comprise the District's basic financial statements and have issued our report thereon dated November 10, 2021. Our report included an explanatory paragraph addressing the District's preparation of its financial statements on the modified cash basis.

Internal Control Over Financial Reporting

In planning and performing our audit of the financial statements, we considered Avenue City R-IX School District's internal control over financial reporting (internal control) to determine the audit procedures that are appropriate in the circumstances for the purpose of expressing our opinions on the financial statements, but not for the purpose of expressing an opinion on the effectiveness of Avenue City R-IX School District's internal control. Accordingly, we do not express an opinion on the effectiveness of Avenue City R-IX School District's internal control.

A deficiency in internal control exists when the design or operation of a control does not allow management or employees, in the normal course of performing their assigned functions, to prevent, or detect and correct, misstatements on a timely basis. A material weakness is a deficiency, or a combination of deficiencies, in internal control such that there is a reasonable possibility that a material misstatement of the entity's financial statements will not be prevented, or detected and corrected, on a timely basis. A significant deficiency is a deficiency, or a combination of deficiencies, in internal control that is less severe than a material weakness, yet important enough to merit attention by those charged with governance.

Our consideration of internal control was for the limited purpose described in the first paragraph of this section and was not designed to identify all deficiencies in internal control that might be material weaknesses or significant deficiencies and therefore, material weaknesses or significant deficiencies may exist that were not identified. Given these limitations, during our audit we did





not identify any deficiencies in internal control that we consider to be material weaknesses. We did identify certain deficiencies in internal control, described in the accompanying schedule of findings and responses as items 2021-1 and 2021-2 that we consider to be significant deficiencies.

Compliance and Other Matters

As part of obtaining reasonable assurance about whether Avenue City R-IX School District's financial statements are free from material misstatement, we performed tests of its compliance with certain provisions of laws, regulations, contracts, and grant agreements, noncompliance with which could have a direct and material effect on the determination of financial statement amounts. However, providing an opinion on compliance with those provisions was not an objective of our audit, and accordingly, we do not express such an opinion. The results of our tests disclosed no instances of noncompliance or other matters that are required to be reported under Government Auditing Standards.

Avenue City R-IX School District's Responses to Findings

Avenue City R-IX School District's responses to the findings identified in our audit are described in the accompanying schedule of findings and responses. The District's responses were not subjected to the auditing procedures applied in the audit of the financial statements and, accordingly, we express no opinion on them.

Purpose of this Report

The purpose of this report is solely to describe the scope of our testing of internal control and compliance and the results of that testing, and not to provide an opinion on the effectiveness of the entity's internal control or on compliance. This report is an integral part of an audit performed in accordance with *Government Auditing Standards* in considering the entity's internal control and compliance. Accordingly, this communication is not suitable for any other purpose.

School Board Candidate Filing Opens in December

It's time to prepare for the April school board election. Candidate filing begins December 7, 2021.

- There are two seats up for election for a three year term.
- The first day of filing begins Tuesday, December 7th, at 8:00 AM.
- Filing will continue during the district's regular business hours, which are Monday through Friday from 8:00 AM to 3:45 PM. Filing will not occur during Christmas break, beginning December 22nd at 1:00 PM through December 27th.
- The closing date for filing is December 28, 2021 at 5:00 PM. Filing will resume at 9:00 AM on Tuesday, December 28, 2021 through 5:00 PM.
- Filing will not occur on days that school is not in session due to inclement weather.
- Candidates may call 816-662-2305 or email jpankau@avenuecityschool.org to inquire if the office is open.





The district will provide each candidate a copy of a summary of campaign laws provided by the Missouri Ethics Commission and written notice of the candidațe's obligation to file a personal financial disclosure statement.

Information on the School Board Organization

The qualified voters of the School District shall annually on the first Tuesday after the first Monday of April, elect two directors for terms of three years, except, effective for Board elections beginning in April of 1993, and each three years thereafter, when three directors shall be elected in compliance with regulations specified in state law.

An election shall not be held if the number of candidates who have filed for the Board is equal to the number of positions available.

Qualified Voters in the School District

An individual must be a registered voter in order to vote in a school election. In order to vote, a person must be eighteen (18) years of age or older, must be a citizen of the United States, and must reside in the School District thirty (30) days.

Candidate Qualification - Method of Filing

Qualified applicants for the Board may file for office beginning at 8:00 a.m. in the Superintendent's office commencing on the seventeenth (17th) Tuesday prior to the election and ending at 5:00 p.m. on the fourteenth (14th) Tuesday before the election. The candidate shall declare his/her intent to become a candidate, in person and in writing to the secretary of the Board of Education. The names of qualified candidates shall be placed on the ballot in the order of filing. The notice of election and certification of candidates must be submitted to the county clerk by the tenth Tuesday prior to the election. Candidates must comply with all of the prevailing laws concerning eligibility and campaign financing.

Candidates must be citizens of the United States and resident taxpayers of the District, reside in his/her state for one year next preceding their election or appointment, and be at least twenty-four (24) years of age. Each newly elected or appointed director shall qualify and take his/her oath of office in the manner prescribed by law and according to Policy 0330 - Oath of Office.

Facts regarding the flu



PARENT/GUARDIAN

Your child may have been exposed to

Influenza (Flu)

Influenza (also known as flu) Is a common viral respiratory infection.

Influenza is not "stomach flu", a term used by some to describe illnesses causing vomiting or diarrhea.

If you think your child has the Flu;

- Tell your childcare provider or call the school.
- · Need to stay home?

Childcare and School:

Yes, until the fever is gone for at least 24 hours and the child is healthy enough for routine activities,

DO NOT give aspirin or salicylate-containing medicines to anyone under 18 years of age.

Symptoms

Your child may have chills, body aches, fever, and headache. Your child may also have a cough, runny or stuffy nose, and sore throat.

Illness may last up to 7 days.

If your child has been infected, it may take 1 to 4 days (usually 2 days) for symptoms to start.

Spread

- By coughing and sneezing.
- By touching contaminated hands, objects or surfaces.

Contagious Period

During the 24 hours before and up to 7 days after the Illness begins,

Call your Healthcare Provider

 If anyone in your home has a high fever and/or coughs a lot. Your doctor may give medications.

Antibiotics do not work for illnesses caused by a virus, including influenza.

Prevention

- Cover nose and mouth when sneezing or coughing. Use a tissue or your sleeve.
 Dispose of used tissues,
- Wash hands after touching anything that could be contaminated with secretions from the nose or mouth. Your child may need help with handwashing.
- DO NOT share anything that goes into the mouth, such as drinking cups, straws, and water bottles,
- Clean and disinfect anything that comes in contact with secretions from the nose or mouth. This includes door knobs, refrigerator handle, water faucets, and cupboard handles. Use a product that kills viruses.
- Annual influenza vaccination is recommended for children 6 months to 18 years of age.
