#### One More Level of COVID-19 Protection



While Andrew County has been relatively COVID-free over the past several months, other communities around our state have not been as fortunate. During a recent regional meeting lead by the Andrew County Health Department, it was learned that Missouri is one of the few states that possesses no expectations concerning people who move into our state from COVID-19 "hot spots."

While our state has no restrictions, the local school districts located in Andrew County have agreed to implement an enrollment policy/regulation until the COVID-19 pandemic runs its course. That policy/regulation is designed to provide one more layer of protection for our children and the school staff. To better ensure the school remains free of potential COVID-19 exposure, students enrolling from non-Missouri Schools will be required to undergo a 7-day waiting period prior to attending school in-person. In addition, students enrolling from Missouri communities that have been identified as "COVID-19 hotspots" or potential "hotspots" will be required to meet the same standard.

Parents/guardians will be required to verify that the enrolling child(ren) has/have been free of COVID-19 symptoms during the 7-day waiting period. Students who are district residents will be provided learning activities during their waiting period.

While this practice does not eliminate the threat of exposure of COVID-19, it does provide one more barrier of protection for our school.

<u>Parents:</u> Please complete this short check with your child each morning. If your child has any of these symptoms, you should contact your physician then contact Mrs. Shawnda Russell, school nurse, to inquire about when your child can return to school.

Section 1: Symptoms: If your child has any of the following symptoms, that indicate a possible illness that may decrease the student's ability to learn and also put them at risk for speeding illness to others. Please check your child for these symptoms.

	Sore throat
	New uncontrolled cough that causes difficulty breathing (for students with chronic allergic / asthmatic cough, a change in their cough from baseline);
	Diarrhea, vomiting, or abdominal pain
	New onset of severe headache, especially with fever

	Muscle Pain
	New loss of taste or smell
Section	2: Close Contact / Potential Exposure Had close contact (within 6 feet of an infected person for at least 15 minutes) with a person with confirmed COVID-19; or
	Had close contact (within 6 feet of an infected person for at least 15 minutes) with person under quarantine for possible exposure to SARS-CoV-2; or
	Traveled to or lived in an area where the local, Tribal, territorial, or state health department is reporting large numbers of COVID-19 cases
	New controlled cough that caused difficulty breathing (for students with chronic allergic / asthmatic cough, a change in their cough baseline);
	Live in areas of high community transmission

#### Avenue City District's Plan for 2020-2021:

<u>Synopsis:</u> Avenue City School will be offering face to face instruction for students beginning August 24, 2020. Answers to questions in regards to maintaining a healthy and safe environment can be found below. If you have any other questions, feel free to contact administration at 816-662-2305.

What are the school hours? School hours are (8:25 AM-3:15 PM; Students can arrive at 8:00 AM)

<u>Is the school planning extended breaks?</u> At this point the district is not planning for extended breaks. The plan is to attend school on the days assigned by the Board of Education Adopted 20-21 School Calendar. You can find the school calendar on the district website.

#### Will my child's temperature be scanned each day?

- If students are brought to school via personal vehicle their temperatures will be scanned. If temperature is below 100.4 degrees F, students will then go directly to breakfast or to their classroom.
- Temperatures will be scanned before children board the bus. It temperature is above 100.4 Fahrenheit the child and their siblings will not be able to board the bus.

#### Will my child be required to wear a mask?

 All students will be required to wear a mask when they are in the hallways, communal spaces, or participating in an activity where social distancing cannot be maintained.

#### What is the district doing about extracurricular events or activities?

- School Aged Childcare (after school) will NOT be provided the 1<sup>st</sup> quarter. We will reassess this decision at the beginning of 2<sup>nd</sup> quarter.
- There will be NO "Back to School Night". There will be a limited Meet and Greet on August 20, 2020.
- Extracurricular Activities: ACES will follow Missouri State High School Activities Association guidelines with regard to extracurricular activities.

Will visitors be allowed in the school building during the school day? Access to the building will be limited to only necessary personnel and students.

<u>What will guidelines be for bus riders?</u> School bus transportation may not readily allow for physical distancing. However, strategies to reduce contact on buses and risk of infection will include:

- Students will have their temperature scanned before they get on bus. If the child is running a temperature of 100.4 or above, the child and their siblings will not be allowed to ride.
- Every child on the bus will have assigned seats. Siblings will be seated together when possible.
- Every child on the bus must wear a mask
- Bus will be loaded from back to front. Students will depart from front to back.
- District will supply bottle of hand sanitizer for each bus. Students will use hand sanitizer when boarding bus.

• Bus Company will be cleaning the bus before and/or after each route.

What if my child is experiencing anxiety at the thought of returning to school? If your child is experiencing anxiety during this time, please contact your child's teacher and/or the school counselor, Ms. Stormie Milne. They can help you and your child develop a plan that will ease their anxiety.

What is my child is on a specialized plan, such as an Individualized Education Plan, a 504, a remedial reading plan? All of these plans are individualized to a particular student. If you have questions about your child's individualized plan – please contact case worker via email. The district professionals will work with other participants on the child's team to meet the needs of the child.

<u>How is the Avenue City District Planning to Maintain a Healthy Environment?</u> District administration, reentry committee members, and board of education are working on a plan to maintain a healthy environment for our students. Please see plan below.

#### Cleanliness

- Staff will clean and disinfect frequently touched surfaces (e.g., playground equipment (after each recess), door handles, desk tops, sink handles) within the school and on school buses at least daily.
- Students will be required to wear mask when they are in hallways, communal spaces, or participating in an activity that social distance cannot be maintained.
- Each student will wash hands each time they enter the classroom, before lunch, after recess, etc.
- Hand Sanitizing Stations will be displayed throughout the school building.
   Everyone will be encouraged to use them.
- Staff will use disinfecting wipes / cleaner on desk tops and frequently touched surfaces numerous times a day.

#### **Shared Objects**

- O Staff will discourage sharing of items, especially items that are difficult to clean or disinfect.
- Staff will keep each child's belongings separated from others' and in individually labeled containers, cubbies, or areas.
- O Staff will ensure adequate supplies to minimize sharing of high touch materials to the extent possible. Avoid sharing electronic devices, toys, books, and other games or learning aids when possible. Wipe down objects prior to sharing.
- o Library books will be wiped down before being placed on shelf for next person.
- Computers keyboards in lab or communal areas will need to be sanitized before each use.

#### Water Systems

Drinking fountains will not be used. Students will provide their own bottled water, may purchase from the cafeteria, or will provide a refillable container and may use the district's refill stations.

#### **Modified Layouts**

 Student desks will face in the same direction (rather than facing each other), or students will sit on only one side of tables, spaced apart when possible.  If classroom is equipped with tables, district will provide dividers that will be placed between each student.

#### **Communal Spaces**

- Recess will be staggered times and classes of students will be guided to different areas of playground.
- Minimal children in restroom at a time.
- Physical Education classes will take advantage of "open air" outside activities when possible.

#### **Food Service**

- Lunch times will be staggered so that there can be more space between students.
- O Use disposable food service items (e.g., utensils)
- Class treats / birthday treats may only be bought / prepackaged / individualized.

#### Gatherings, Visitors, and Field Trips

- District will limit any nonessential visitors, volunteers, field trips, and activities involving external groups or organizations.
- When preschool students enter and exit building, staff member will meet students at door and escort them to class.

#### Identifying Small Groups and Keeping Them Together (Cohorting)

- o Ensure that student and staff groupings are as static as possible by having the same group of children stay in the same room.
- Mixing between groups will be avoided when at all possible. ACES cohorts will be limited when there is a mix of groups it will be K-2; 3-5, 6-8. (For example: Kindergarten, 1<sup>st</sup> Grade, 2<sup>nd</sup> Grade will go to recess at the same time, however they will be assigned to different areas of the playground to avoid unnecessary contact.)

#### **COVID-19 Point of Contact**

- All school staff and families will notify school nurse in the event that if they (staff) or their child (families) become sick with COVID-19 symptoms, test positive for COVID-19, or have been exposed to someone with COVID-19 symptoms or a confirmed or suspected case.
- o If child becomes ill at school, he/she will immediately be removed from classroom; will be quarantined to nurse's office with a mask until parents arrive.
- Once sick child leaves premises the area will be closed off and not used until after cleaning and disinfecting.
- Administration will work with county officials to communicate to others who were exposed to positive case.
- Administration will notify staff, families, and the public of school closures and any restrictions in place to limit COVID-19 exposure (e.g., limited hours of operation).
- If a student or staff member at Avenue City School is identified as positive for COVID-19, administration will work with the Andrew County Health Department to follow correct protocol.

#### Recognize Signs and Symptoms

- Students will have temperature checks before entering building or boarding school bus each morning.
- School will supply each parent with "symptoms checker" identification sheet to be used before school each day.
- o All students must fill out COVID-19 questionnaire upon registration.

#### Education

- Visual aides will be posted around school for reminders of social distancing, hand washing, cover your cough, mask wearing, etc.
- Administration will post on social media / school website education in regards to "stopping the spread" of COVID-19.

What if I do not feel that it is safe for my child to return to school? Avenue City Elementary School District will be offering face-to-face instruction ONLY. If you do not feel that it is safe for your child to attend, you may decide to homeschool. Please note that if you homeschool during the 20-21 school year and then decide that your child will return to ACES during the 21-22 school year, we will administer a placement test. Based on that test, administration will decide grade placement of your child.

This is a very fluid situation. The Avenue City School District reserves the right to adjust this plan as new information becomes available or situations change.

#### PUBLIC NOTICE

All responsible public agencies are required to locate, evaluate, and identify children with disabilities who are under the jurisdiction of the agency, regardless of the severity of the disability, including children attending private schools, children who live outside the district but are attending a private school within the district, highly mobile children, such as migrant and homeless children, children who are wards of the state, and children who are suspected of having a disability and in need of special education even though they are advancing from grade to grade. The Avenue City School District assures that it will provide a free, appropriate public education (FAPE) to all eligible children with disabilities between the ages of 3 and 21 under its jurisdiction. The Avenue City School District assures that it will provide information and referral services necessary to assist the State in the implementation of early intervention services for infants and toddlers eligible for the Missouri First Steps program.

The Avenue City School District assures that personally identifiable information collected, used, or maintained by the agency for the purposes of identification, evaluation, placement or provision of FAPE of children with disabilities may be inspected and/or reviewed by their parents/guardians. Parents/guardians may request amendment to the educational record if the parent/guardian believes the record is inaccurate, misleading, or violates the privacy or other rights of their child. Parents have the right to file complaints with the U.S. Department of Education or the Missouri Department of Elementary and Secondary Education concerning alleged failures by the district to meet the requirements of the Family Educational Rights and Privacy Act (FERPA).

The Avenue City School District has developed a Local Compliance Plan for the implementation of State Regulations for the Individuals with Disabilities Education Act (IDEA). This plan contains the agency's policies and procedures regarding storage, disclosure to third parties, retention and destruction of personally identifiable information and the agency's assurances that services are provided in compliance with the General Education Provision Act (GEPA). This plan may be reviewed during school hours at

Children from families whose current income is at or below those shown are eligible for free or reduced price meals. Applications are available at the school office. To apply, fill out a Free and Reduced Price School Meals Family Application and return it to the school. The information provided on the application is confidential and will be used only for the purpose of determining eligibility. Applications may be submitted any time during the school year. A complete application is required as a condition of eligibility. A complete application includes: (1) household income from all sources or Food Stamp/TANF case number, (2) names of all household members, and (3) the signature and last four digits of social security number or indication of no social security number of adult household member signing the application. School officials may verify current income at any time during the school year.

Foster children may be eligible regardless of the income of the household with whom they reside.

If a family member becomes unemployed or if family size changes, the family should contact the school to file a new application. Such changes may make the children of the family eligible for these benefits.

Households will be notified of their children's eligibility status for free or reduced price meals. If any children were not listed on the eligibility notice for families receiving SNAP, TANF or FDPIR, the household should contact the school to have free meal benefits extended to those children.

If any child (ren) was not listed on the eligibility notice, the household should contact the LEA or school to have free meal benefits extended to that child (ren).

Under the provisions of the policy, the **Administrative Assistant** will review the applications and determine eligibility. If a parent is dissatisfied with the ruling of the determining official, they may wish to discuss the decision with the hearing official on an informal basis or he/she may make a request either orally or in writing to the **Building or District Administrator**.

Hearing procedures are outlined in the policy. A complete copy of the policy is on file in each school and in the central office where any interested party may review it.

#### **USDA Non-discrimination Statement:**


