# Why does an initial evaluation happen?

01

#### A Parent Concern

As a parent you can request an evaluation if you have educational concerns for your student.

02

#### A Teacher Concern

If a teacher has tried in classroom accommodations that are not helping the student learn, and have concerns with academics, she can request an evaluation.

## When A Parent Requests an Evaluation



Within 5 school days of your request you will be given a packet of Procedural Safeguards and Parent Bill of Rights.



Special Education teachers will gather information YOU about your concerns, the student's Meeting/ teacher about her concerns, and the student's accumulation folder. This information will be discussed at a meeting to determine if the school staff "has a reason to suspect a disability." This meeting may be held with parents, or may be held as just district staff.

#### Does staff determine there is a "Reason to Suspect a Disability?"

YES Continue to the next bullet point.

The process STOPS. Staff will give YOU a document called the Notice of Action. This document will explain why staff do not suspect a disability. You will get this within 30 days of your initial request for evaluation.



Special Education teachers will collect more data about how your student is doing from you and teachers.



Within 30 days a Review of Existing Data is conducted. This begins the official process. This Meeting! meeting the team will discuss all of the additional data that was collected and determine what testing will be necessary. This can be complete with or without a meeting.

#### Is there more testing that needs to be completed?





You will be given a Notice of Action that states there is no additional testing that needs to happen to determine eligbilty.

## When A Teacher Requests an Evaluation



Special Education teachers will gather information from the teacher about hers concerns, and the student's accumulation folder. This information will be discussed at a staff meeting to determine if the school staff "has a reason to suspect a disability." This meeting may be held with parents, or may be held as just district staff.

#### Does staff determine there is a "Reason to Suspect a Disability?"

YES

Continue to the next bullet point.



Within 5 school days of the school determining there is a reason to suspect a disability you will be given a packet of Procedural Safeguards and Parent Bill of Rights.



Special Education teachers will collect more data about how your student is doing from you and teachers through a legnthy form.



Within 30 days a Review of Existing Data Meeting is conducted. This begins the official Meeting process. At this meeting the team will discuss all of the additional data that was collected and determine what testing will be necessary. This can be completed with or without a meeting.

#### Is there more testing that needs to be completed?

#### **YES**

You will be given a Notice of Action that states what testing will occur in order to determine if your child can be in special education. \*In order for testing to occur you MUST sign consent.

THEN testing will be scheduled for your student.

#### <u>NO</u>

You will be given a Notice of Action that states there is no additional testing that needs to happen to determine eligbilty.



Upon receipt of your consent, the school staff will schedule testing for your child. Your child will take an assessment in all areas that your consent was given for as documented in the Notice of Action you signed.



Within 60 days from your sign consent for testing or signed consent for no testing there Meeting! will be an Evaluation Determination Meeting. At this meeting the team will discuss if your student can be in special education (determination is based off of Missouri Standards and Indicators).

### So What?

#### <u>lf your</u> student **qualifies**

After you sign permission for your student to be in special education...

The meeting will switch directly into an IEP Meeting OR An IEP Meeting will be scheduled within the next 30 days.

#### <u>lf your student</u> <u>does **not qualify**</u>

You can choose to sign permission for your student to be taken out of Special Education before the 10 day waiting period.

Your student is no longer in Special Education and will receive all instruction and support within their regular classroom. Interventions in that classroom will be put into place.
